Our many Licensed Counselors, Certified Therapeutic Recreational Specialists, Retreat Managers, along with our team of Relationship Reset facilitators, military veterans themselves, could not do what we do without our amazing volunteers, who give so much support the military families we serve.

> **Project Sanctuary met increasing financial** challenges by achieving two major milestones this past year:

OPERATING RESERVE FUND: Another

milestone was reached as Project Sanctuary met the challenge presented by The Kendeda Fund to create our first ever Operating Reserve Fund. This was an amazing opportunity for Project Sanctuary to help solidify the foundation of our financial strength and enabled us to put aside three months of operating expense should we experience any unforeseen financial obstacles.

RETREAT CENTER ACQUISITION: The year

ended securing a retreat center in Pagosa Springs, Colorado which will end up being the new home base for Project Sanctuary Therapeutic Retreats and provide a home for military families for years to come. Two amazing donors led the way to making this dream a reality for our organization and our Board of Directors stepped up to close the gap to finalize the purchase of this retreat center in November 2023. We are one of few retreat centers dedicated to support military families across the country. More to come in 2024 and beyond.

Recreational therapy, also known as therapeutic recreation, is a systematic process that utilizes recreation and other activity-based interventions to address the assessed needs of individuals with illnesses and/or disabling conditions, as a means to psychological and physical health, recovery and well-being.

Project Sanctuary Certified Therapeutic Recreational Specialists (CTRS) plan each retreat for military families with intentional recreation

designed to compliment workshops and teach skills to help families navigate challenges around mental health, communication, and building stronger relationships all while gaining tools to take home to make recreation a part of their daily lives and continued healing.

The CTRS team also leads the youth program and partners with Licensed Counselors to lead the teen program during retreat. At the end of the retreat, youth and teens are asked a series of questions to understand their experience with the program. Following is what we heard from our youth and teens in 2023.

Impact

Of the servicemen and women Project Sanctuary served over the past year, 86% self-reported a service-connected injury, 76% self-reported mental health issues, and 67% self-reported physical injuries / limitations. Of the 34 participants who did not self-report a service-connected injury, 24 were still active duty.


icensed counselors & social workers

Licensed Counselors & Social Workers lead adult and teen workshops focused on mental health and offer one on one sessions to families or individuals throughout the week to discuss personalized topics.

In 2023 Licensed Counselors spent **438.5 hours** with families during therapeutic retreats on personalized issues directly impacting their family.

From 2021 – 2023 Licensed
Counselors spent a total of
1670 hours in family sessions
during therapeutic retreats. Year
over year, we are seeing this
number increase.

Launched in Fall 2022, Project Sanctuary is now able to determine improvements in areas that play a key factor in connectedness, helping to build stronger, healthier family bonds. The analysis was initially set up with the help of Dr. Jasmine Townsend, Board Member and Associate Professor of Recreational Therapy, at Clemson University in South Carolina. The first year of results yielded the following outcomes:

NOVEMBER 2022 — JANUARY 2024 RETREAT SURVEY RESULTS

SURVEYS GIVEN IMMEDIATELY:

35.5% increase in positive perception of family communication & 20.9% decrease in problematic family functioning.

THREE MONTHS POST-RETREAT:

29.3% increase in positive perception of family communication & 15.8% decrease in problematic family functioning.

SIX MONTHS POST-RETREAT:

23% increase in positive perception of family communication & 14% decrease in problematic family functioning.

12 MONTHS POST-RETREAT:

32% increase in positive perception of family communication & 27% decrease in problematic family functioning.

The following average scores were reported for the 2023 retreat season in the wrap-up survey:







Thanks to the vision and investment of very special donors, Project Sanctuary is now the proud owner of a 42-acre retreat center in Pagosa Springs, Colorado. Fred & Linda Milanovich have a deep passion for service and when they learned about founder, Heather Ehle Ray's dream for Project Sanctuary to one day own a retreat center, specifically to meet the needs of military families. Fred & Linda provided the initial \$1 million investment and the search for the perfect property began.

Along the journey, Project Sanctuary was fortunate to connect with the Bill Ackerman Charitable Fund. During his life, Mr. Ackerman served in the military and carried with him a passion to help vulnerable children. In learning about the vision for this new retreat center, a partnership evolved. Project Sanctuary will be able to continue to honor Mr. Ackerman through our service to military children and families at the new retreat center. An additional \$1 million gift supported the acquisition of Project Sanctuary's new home base.

The Project Sanctuary Board of Directors, in addition to a few other friends of Project Sanctuary finalized the dream with their capital commitments.

What's Next...

March 2024 Project Sanctuary signed an agreement with Root Design (www.rootdesigncompany.com) to help put together the design of needed renovations to provide a family focused atmosphere and lodging experience to support and honor the families who have given so much serving our great country.
